1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GRAVES ENGINEERING, INC., a California Corporation, to provide professional engineering services for the Imperial Beach Gardens Drainage Study, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 259205 .

2. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$20,000 from Fund 18518, Dept. 5613, Org. 1305, CY '82 year, CDBG Funds for the San Ysidro Boulevard widening project to Fund 18518, Dept. 5613, Org. 1311 Imperial Beach Gardens Drainage Study, CIP 12-023.

3. That the expenditure in the sum of \$20,000 from Fund 18518, Dept. 5613, Org. 1311; CIP 12-023, Imperial Beach Gardens Drainage Study and \$860 from CIP 58-007 Overhead and Other Costs for Projects Funded by Federal Grants, Fund 30245 exclusively is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.

4. That the Auditor and Comptroller be and he is hereby authorized to add CIP 12-023 "Imperial Beach Gardens Drainage Study" to the FY '84 CIP Program.
