RESOLUTION NUMBER R- 259217

Adopted on SEP 12 1983

WHEREAS, the Council of The City of San Diego desires that any person, firm or agency conducting clean-up operations at an abandoned hazardous waste disposal site shall do so in a manner which will not jeopardize the safety or property of citizens of the City of San Diego; and

WHEREAS, Section 25180 of the Health and Safety Code specifically provides the local Health Officer with the authority to enforce the minimum standards and regulations adopted by the State of California Department of Health Services relating to hazardous and extremely hazardous wastes; and

WHEREAS, the State of California Department of Health Services and the County of San Diego Department of Health Services have entered into an agreement to cooperate in the enforcement of State and local hazardous waste program requirements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby requests the Director of the County of San Diego Department of Health Services to require any person responsible for the clean-up operation at an abandoned hazardous waste disposal site to develop a site clean-up operations plan for review prior to starting operations. Such plan should include beginning and ending dates of operation; hours of operations, and emergency procedures.

BE IT FURTHER RESOLVED, that the Council further requests the Director of the County of San Diego Department of Health Services to submit a copy of this site clean-up operations plan to the City Manager for review and recommendations prior to the commencement of the clean-up operation unless considerations dictate otherwise.


BE IT FURTHER RESOLVED, that the Council further requests that following the submission of the clean-up plan to the City Manager, the Director of the County of San Diego Department of Health Services shall contact the Police Department, Fire Department and other appropriate agencies to convene a meeting to develop an emergency contingency plan prior to the commencement of the clean-up operation. It is desired that the emergency contingency plan shall include but not be limited to provisions for:

1. Notifying area residents and businesses of the clean-up operations prior to commencement.
2. A warning system that will alert area residents and businesses in the event of an emergency.
3. On-site safety monitoring approved or conducted by the County Department of Health Services.

BE IT FURTHER RESOLVED, that the Director of the County of San Diego Department of Health Services request of any person responsible for the clean-up operation to provide a final report following the conclusion of the clean-up operation. A copy of the report shall be delivered to the City Manager upon his request.
