APPROVING MAP OF VICTORIA MANOR

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Gary L. Hay, a registered Civil Engineer, entitled "VICTORIA MANOR, being a subdivision of portions of Quarter Section Lots 82 and 83 of Rancho de la Nacion, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 166, filed in the office of the County Recorder of San Diego County, May 11, 1869, together with a portion of Tonawanda Drive as dedicated to public use and a portion of Tonawanda Drive as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Redford Place, Cameron Court, and a portion of Tonawanda Drive; and said streets and portion of street are hereby declared to be public streets and portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Tonawanda Drive approved by Council Resolution No. R-258985 on


AUG 1 1983 concurrently with the filing of the map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated.
