RESOLUTION CONCERNING REDOCUMENTATION OF CUNARD
PRINCESS AND CUNARD COUNTESS.

WHEREAS, the cruise industry on the west coast of the United States is experiencing significant growth in terms of vessel tonnage and passengers; and

WHEREAS, Cruise America Line, Inc. has applied for redocumentation of two modern passenger vessels, the CUNARD PRINCESS and THE CUNARD COUNTESS, to United States Flag; and

WHEREAS, documentation of these vessels will require federal legislation to permit entry into the coastwise trade and appropriate bills have been introduced in the United States Senate and United States House of Representative; and

WHEREAS, calls from such vessels in San Diego would result in greater revenues to the City of San Diego, increase job opportunities for San Diego residents and be a potential source of additional work and revenue for local master ship repair firms; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council supports the redocumentation of the CUNARD PRINCESS and the CUNARD COUNTESS as United States Flag vessels, thereby permitting them to operate in United States coastwise trade as provided for in S. 1197 and H.R. 2883.
