WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Judith L. Stone	Attorney	\$ 480	Ms. Stone is a Senior Typist. She suggested that all felony drops be sent "notify warrant" automatically. This is expected to save \$3,180.96 in the first year in costs for time, material and equipment. This is a partial award pending a final 12 month review.
John M. Cortez	Park & Recreation	\$ 475	Mr. Cortez is a Grounds Maintenance Worker III. One year ago he earned a partial award of \$415 for his suggestion to convert the sprinkler heads to testing heads. One year's experience has shown a savings of \$2,970. This is the remainder of his award.
John R. Crowell	Police	\$ 450	Mr. Crowell was an Evidence Technician at the time this suggestion was submitted. He suggested the development of an in-house finger print powder. This is expected to save \$2,989 in the first year in material costs. This is a partial award pending a final 12 month review.
Gail F. Jeromin	Planning	\$ 440	Ms. Jeromin was a Zoning Representative at the time this suggestion was submitted. She suggested that an additional charge should be assessed for variances and conditional use permits. This is expected to result in an increase in revenue of \$2,915 in the first year. This is a partial award pending a final 12 month review.
