WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Matthew E. Weathersby	Police	\$ 250	Mr. Weathersby is a Police Officer. He suggested that child safety car seats be purchased by the Police Department. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Mary D. Bush	Auditor & Comptroller	\$ 225	Ms. Bush is a Senior Account Clerk. She suggested that an "Outstanding Accounts Receivable Invoice Listing" be run at the end of the year for reconciling and auditing purposes. This is expected to save \$742.82 in the first year in labor costs.
Joe A. Pirronello	Fire	\$ 200	Mr. Pirronello is a Captain. He suggested that Fire personnel witness and mark hoses tested at the factory instead of re-testing the same hoses here upon delivery. Although savings were difficult to identify this was considered to be a significant operational improvement.
James J. Darrach	General Services	\$ 175	Mr. Darrach is a Communications Technician in the Communications and Electrical Division. He suggested that the High-Gain Antenna be installed on the trunk of the Patrol Cars. This is expected to save \$584.50 in the first year in costs for time, material and equipment.
