Ronald E. Keith	Fire	\$ 175	Mr. Keith is a Firefighter. One year ago he earned a partial award of \$180 for his suggestion to install and direct wire the automatic door controller to the batteries on the Fire Apparatuses. One year's experience has shown a savings of \$1,180.75. This is the remainder of his award.
Grant W. Jackson	Water Utilities	\$ 50	Mr. Jackson is a Utility Worker. He suggested that a fence be installed on Otay Valley Road by the pipeline to prevent illegal dumping. Although savings were difficult to identify this was considered to be a significant operational improvement. This is a partial award pending a final 12 month review.
Larry R. Carlson	Fire	\$ 50	Mr. Carlson is a Firefighter. He suggested that an information training course be established regarding the Metro Arson Strike Team. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Ellen O. Duff	Property	\$ 30	Ms. Duff is a Senior Clerk. One year ago she earned a partial award of \$20 for her suggestion to revise the routing procedure for chronological files. One year's experience has shown a savings of \$518.61. This is the remainder of her award.
