WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Amelia A. Garza	Police	\$ 30	Ms. Garza is a Data Entry Operator. One year ago she earned a partial award of \$95 for her suggestion to eliminate the lighting in the display cases at the Central Police Department. One year's experience has shown a savings of \$413.70. This is the remainder of her award.
Robert L. Davis	General Services	\$ 30	Mr. Davis is a Plumbing Supervisor in the Building Division. One year ago he earned a partial award of \$105 for his suggestion to install a timer on the heater located in the restroom in Building #41. One year's experience has shown a savings of \$445. This is the remainder of his award.
Allen P. Stalnaker	Fire	\$ 30	Mr. Stalnaker is a Fire Engineer. He suggested that a light switch be installed in the walkway at Fire Station #10. This is expected to save \$103 in the first year in energy costs.
Perry A. Peake	Fire	\$ 25	Mr. Peake is a Firefighter. He suggested that a portable radio charging unit be installed in Rescue #14. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
