<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Ted Myrus	General Services	\$ 25	Mr. Myrus is a Repair Supervisor in the Equipment Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to install brake shoe rivet plugs on trucks equipped with air brakes. Although savings were difficult to identify, this was considered to be a significant operational improvement. This is the remainder of his award.
Andre B. Goodwin	General Services	\$ 25	Mr. Goodwin is a Senior Motive Service Technician in the Equipment Division. He suggested that the transmission filters on the 5700 packers be relocated. This is expected to save \$202 in the first year in costs of time and equipment.
Perry A. Peake	Fire	\$ 25	Mr. Peake is a Fire-fighter. He suggested that an external speaker be installed in rescue #14. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Terra L. Kaysser	Building Inspection	\$ 25	Ms. Kaysser is a Junior Typist. She suggested that a biweekly newsletter be published for the public and City personnel. Although savings were difficult to identify, this was considered to be a significant communication improvement.
