

RESOLUTION NUMBER R- 259239

Adopted on SEP 13 1983

BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on April 14, 1983, to consider two proposed amendments to the MIRA MESA COMMUNITY PLAN; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of two amendments to the MIRA MESA COMMUNITY PLAN; and

WHEREAS, City Council Policy 600-7, requires that the public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, the Planning Commission of The City of San Diego has held concurrent public hearings to consider the amendments to the MIRA MESA COMMUNITY PLAN and amendment of the GENERAL PLAN in order to retain consistency between said plans; and

WHEREAS, on April 14, 1983, the Planning Commission approved and recommended for adoption by the City Council an amended GENERAL PLAN; and

WHEREAS, California Government Code, Section 65869 provides that mandatory elements of the GENERAL PLAN may not be amended more than three times per year; and

WHEREAS, it is the intention of the City Council to

consider amendments to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semi-annual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the amendments to the MIRA MESA COMMUNITY PLAN; and

WHEREAS, the Council of The City of San Diego, by majority vote, approved the amendment to the MIRA MESA COMMUNITY PLAN, except for the location of the third community park site which shall be the subject of a further public hearing on December 13, 1983; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:


1. That this Council hereby approves the amendment of that plan entitled MIRA MESA COMMUNITY PLAN, by incorporation of the industrial element amendment, a copy of which is on file in the office of the City Clerk as Document No. RR- 259239.

2. That the amendment to the MIRA MESA COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans, an omnibus hearing on this and other amendments having been scheduled on or about June 1984.

3. That the approval of the MIRA MESA COMMUNITY PLAN herein contained does not include approval of the third community park site.
