BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT MIRA MESA BOULEVARD AND PARKDALE AVENUE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$90,000.00 from Capital Outlay Fund 30245, CIP No. 61-001 SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN CHANGES IN TRAFFIC PATTERNS/ VOLUMES is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
