That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for THE WOODS AT SCRIPPS RANCH UNIT NO. 5, on file in the office of the City Clerk as Document No. RR-254148, to provide for the substitution of SCRIPPS RANCH ASSOCIATES, a joint venture, comprised of Hermes Financial Corporation and Coventry West Homes, Inc., both California corporations, for SCRIPPS RANCH ASSOCIATES, a joint venture, comprised of Warmington Entities, a California General Partnership, and Hermes Financial Corporation, a California corporation, as subdivider.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by SCRIPPS RANCH ASSOCIATES, a joint venture, as provided by the amendment to the subdivision agreement, on file in the office of the City Clerk as Document No. RR-


