WHEREAS, SCRIPPS RANCH ASSOCIATES, a joint venture, formerly comprised of Warmington Entities, a California General Partnership, and Hermes Financial Corporation, a California corporation, subdivider of THE WOODS AT SCRIPPS RANCH UNIT NO. 3, under an agreement filed in the office of the City Clerk as Document No. RR-252089, was required to install certain improvements in said subdivision; and



That SCRIPPS RANCH ASSOCIATES, a joint venture, subdivider of THE WOODS AT SCRIPPS RANCH UNIT NO. 3, under that certain amended agreement made with THE CITY OF SAN DIEGO, on file in the office of the City Clerk as Document No. RR-259252, is hereby granted an extension of time to May 31, 1985, within which to complete the improvements required by said agreement.
