
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a contract with RETC to continue the Street Youth Program for three months, from October 1, 1983 to December 31, 1983, under the terms and conditions set forth in the contract on file in the office of the City Clerk as Document No. RR- 259266.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$50,279 from RETC, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to expend \$37,500 in 1983 CDBG matching funds (Fund 18519, Dept. 5714, Org. 1407) to continue the Street Youth Program for three months, from October 1, 1983 to December 31, 1983.
