
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

LEGAL DESCRIPTION FOR ROAD DEDICATION

PARCEL 1 - ADMIRAL BAKER ROAD

THAT PORTION OF LOT 49 OF THE PARTITION OF RANCHO MISSION OF SAN DIEGO, S.C.C. 348 IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA ACCORDING TO MAP THEREOF NO. 330, FILED JANUARY 14, 1886 IN THE OFFICE OF THE COUNTY RECORDER OF SAN DIEGO, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF HILLTOP SUBDIVISION, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA ACCORDING TO MAP THEREOF NO. 9577 RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY ON FEBRUARY 26, 1980 AS FILE NO. 80-064646, SAID POINT OF BEGINNING BEING ON A 2140.00 FOOT RADIUS CURVE CONCAVED SOUTHEASTERLY, A RADIAL TO SAID POINT BEARS NORTH 11°29'07" WEST; THENCE, ALONG THE EASTERLY BOUNDARY OF SAID HILLTOP SUBDIVISION, NORTH 23°13'45" EAST, 90.96 FEET TO A NON-TANGENT, 900.00 FOOT RADIUS CURVE CONCAVED NORTHWESTERLY, A RADIAL TO SAID CURVE BEARS SOUTH 73°19'00" EAST; THENCE NORTHERLY ALONG SAID CURVE, 164.56 FEET THROUGH A CENTRAL ANGLE OF 10°28'35" TO THE TRUE POINT OF BEGINNING; THENCE CONTINUING ALONG SAID CURVE, 220.48 FEET THROUGH A CENTRAL ANGLE OF 14°02'11"; THENCE LEAVING SAID CURVE, NORTH 17°52'10" WEST, 232.19 FEET; THENCE NORTH 7°35'59" EAST, 177.27 FEET; THENCE NORTH 18°00'01" EAST, 149.80 FEET; THENCE SOUTH 53°21'02" EAST, 20.48 FEET; THENCE SOUTH 3°44'22" EAST, 71.81 FEET; THENCE SOUTH 18°00'01" WEST, 92.52 FEET TO A TANGENT, 477.00 FOOT RADIUS CURVE, CONCAVED EASTERLY; THENCE, SOUTHERLY ALONG SAID CURVE, 241.43 FEET, THROUGH AN ANGLE OF 29°00'01", THENCE SOUTH 11°00'00" EAST, 290.00 FEET TO A TANGENT, 61.00 FOOT RADIUS CURVE CONCAVED NORTHWESTERLY; THENCE SOUTHWESTERLY ALONG SAID CURVE 71.85 FEET, THROUGH A CENTRAL ANGLE OF 67°29'21"; THENCE SOUTH 56°29'21" WEST, 2.94 FEET TO THE TRUE POINT OF BEGINNING.
