RESOLUTION NUMBER R- 259299

WHEREAS, water, drainage, access and non-motor vehicular and pedestrian easements were acquired for an earlier development in the area of the subdivision known as The Plaza at La Jolla Village; and

WHEREAS, the present development of the property requires the quitclaiming of said easements; and

WHEREAS, the aforementioned easements will no longer serve the public purpose for which they were acquired; and

WHEREAS, the City has no present or prospective public use for said easements, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, said easements were acquired at no cost and THE PLAZA AT LA JOLLA VILLAGE ASSOCIATES, a general partnership, has paid all City costs in connection with processing the matter of quitclaiming said easements; and

WHEREAS, the processing costs of the abandonment will be the consideration for the sale of the City's rights; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San

Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 259299 -1, quitclaiming to THE PLAZA AT LA JOLLA VILLAGE ASSOCIATES, a general partnership, all the City's right, title and interest in the water, drainage, access and non-motor vehicular and pedestrian easements, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
