BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of NATIONAL STEEL AND SHIPBUILDING COMPANY, a Nevada corporation, executed in favor of The City of San Diego, bearing date of August 31, 1983, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 259302, granting to said City an easement for public street purposes in portions of Lots 1, 47 and 48 of Block 77 of San Diego Land and Town Company's Addition to San Diego, Map 379, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SCHLEY STREET.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
