RESOLUTION NUMBER R- 259306

Adopted on SEP 26 1983

BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, The City of San Diego is the owner of a portion of Main Street between Schley and 27th Streets, in the Barrio Logan area; and

WHEREAS, the City desires to negotiate the sale of said land to NATIONAL STEEL AND SHIPBUILDING COMPANY, a Nevada corporation, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by staff appraisal on May 19, 1983, is SEVEN THOUSAND NINE HUNDRED DOLLARS (\$7,900); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No.

RR- 259306 , be, and the same is hereby authorized to be

sold by negotiation for the sum of SEVEN THOUSAND NINE HUNDRED DOLLARS (\$7,900) to NATIONAL STEEL AND SHIPBUILDING COMPANY, a Nevada corporation.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 259306, granting to NATIONAL STEEL AND SHIPBUILDING COMPANY, a Nevada corporation, a portion of Main Street, as more particularly described in said grant deed.

3. That no broker's commission shall be paid by The City of San Diego on the herein-described negotiated sale.

4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
