RESOLUTION APPROVING THE APPLICATION FOR GRANT FUNDS UNDER THE ROBERTI-Z'BERG URBAN OPEN-SPACE AND RECREATION PROGRAM

WHEREAS, the legislature of the State of California has enacted the Roberti-Z'berg Urban Open-Space and Recreation Program, which provides funds to certain political subdivisions of the State of California for acquiring lands and for developing facilities to meet urban recreation needs; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State

Department of Parks and Recreation require the applicant to

certify by resolution the approval of applications prior to

submission of said applications to the state; and

WHEREAS, said applications contain a certification that the applicant will comply with all federal, state and local environmental, public health, relocation, affirmative action and clearinghouse requirements and all other appropriate codes, laws and regulations prior to the expenditure of the grant funds; and

WHEREAS, the project(s) applied for under this program must be of a high priority and satisfy the most urgent park and recreation needs with emphasis on unmet needs in the most heavily populated areas; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego hereby:

- 1. Approves the filing of an application for funding under the Roberti-Z'berg Urban Open-Space and Recreation Program; and
- 2. Certifies that said agency understands the general provisions of the agreement; and
- 3. Certifies that said agency has or will have sufficient funds to operate and maintain the project(s) funded under this program; and
- 4. Certifies that said agency has or will have available prior to commencement of any work on the project(s) included in this application matching money from a nonstate source; and
- 5. Certifies that the project(s) included in this application conform to the recreation element of any applicable city or county general plan; and
- 6. Appoints the City Manager as agent of The City of San Diego to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, payment requests and so on which may be necessary for the completion of the aforementioned project(s); and
- 7. Appoints the City Attorney as legal counsel for said agency with authorization to sign the certification on page 1 of the application.

BE IT FURTHER RESOLVED, that the City Manager is hereby

authorized to submit an application for SB 174 Eighth Year (FY 84) funding for Canyonside Community Park under the Roberti-Z'berg Urban Open Space and Recreation Program Act (SB 174).

BE IT FURTHER RESOLVED, that the addition of CIP No. 29410.1, Canyonside Community Park Comfort Station, to the Fiscal Year 1984 Capital Improvements Program is hereby authorized.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$80,332 from the Capital Outlay Fund Reserve (CIP No. 90-245) to CIP No. 29410.1, Canyonside Community Park Comfort Station.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to reimburse the Capital Outlay Fund Reserve when the \$80,332 in SB 174 funding is received by the City Treasurer.

BE IT FURTHER RESOLVED, that the City Manager or his representative is hereby authorized to perform all necessary acts to secure the funds for these projects.
