BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for

IRRIGATION RECONSTRUCTION 9-HOLE GOLF COURSE BALBOA PARK, San
Diego, California

filed in the office of the City Clerk of the City of San Diego, California, on September 26, 1983 and bearing official Document No. W.O. 117517 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

IRRIGATION RECONSTRUCTION 9-HOLE GOLF COURSE BALBOA PARK.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$166,300.00 from Balboa Park Golf Course Fund 10531 to CIP No. 21-004.2 MUNICIPAL GOLF COURSE - IRRIGATION SYSTEM.

BE IT FURTHER RESOLVED, that the total expenditure of \$450,000.00 from CIP No. 21-004.2 MUNICIPAL GOLF COURSE - IRRIGATION SYSTEM, not to exceed \$283,700.00 from Capital Outlay Fund 30245 and \$166,300.00 from Balboa Park Golf Course Fund 10531 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to reimburse Capital Outlay Fund 30245 an amount not to exceed 50% of the total project cost from Balboa Park Golf Course Fund 10531 less \$166,300.00 previously transferred from Balboa Park Golf Course Fund 10531 to CIP No. 21-004.2 MUNICIPAL GOLF COURSE - IRRIGATION SYSTEM.
