RESOLUTION NUMBER R- 259327

APPROVING MAP OF PARADISE PLAZA

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Glenn R. Ferguson, a licensed land surveyor, entitled "PARADISE PLAZA, being a subdivision of a portion of quarter section Lot 78 of Rancho de la Nacion, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 166 filed in the office of the County Recorder of San Diego County, May 11, 1869, together with a portion of Woodman Street as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Plaza Taxco, Plaza Cuernavaca, Plaza Cuernavaca Way, Plaza Boulevard, Carefree Drive, Plaza Torreon, Plaza Toluca and a portion of Varney Drive, and said streets and said portion of street are hereby declared to be public streets and a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Plaza Boulevard,

adjacent and contiguous to Lots 4, 67 through 93, inclusive, 121, 124 and 134; in and to Woodman Street, adjacent and contiguous to Lots 107 through 109, inclusive, and 128 through 134, inclusive.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
