WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Robert C. Hauptman	General Services	\$2,125	Mr. Hauptman is a Refrigeration Mechanic in the Buildings Division. He suggested that the 60-ton refrigeration compressor at the San Ysidro Community Center be replaced with a 30-ton compressor. This is expected to save \$14,153.22 in the first year in energy costs. This is a partial award pending a final 12 month review.
James K. McCormick	General Services	\$1,630	Mr. McCormick is a Building Manager in the Buildings Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to reduce the lighting at the Central Police Department. One year's experience has shown a savings of \$5,439.05. This is the remainder of his award.
Jim A. Toci	General Services	\$1,000	Mr. Toci is an Assistant Electrical Engineer in the Communications and Electrical Division. He suggested that all existing recreational lighting be changed to high pressure sodium light sources. This is expected to save \$41,600 in the first year in energy costs.
