David E. Mauldin	General Services	\$ 960	Mr. Mauldin is a Welder in the Equipment Division. One year ago he earned a partial award of \$965 for his suggestion to install a plate underneath the oil tank sight gauge on the trash packers to reduce breakage. One year's experience has shown a savings of \$6,408.51. This is the remainder of his award.
Gail F. Jeromin	Planning	\$ 565	Ms. Jeromin was a Zoning Representative at the time this suggestion was submitted. She suggested that an additional charge should be assessed for illegal subdivision directional signs. This is expected to result in an increase in revenue of \$3,750 in the first year. This is a partial award pending a final 12 month review.
Theodore O. Brinks	Police	\$ 535	Mr. Brinks is a Police Officer. He suggested that the vehicle thefts be eliminated from the Investigative Supplementa This is expected to save \$1,791.40 in the first year in costs for time and material.
