


RESOLUTION No. R-259347 (R-84-401)

Adopted on OCT 10 1983

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of ENVIRON. MAINT. SERVICE SPEC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing JANITORIAL SERVICES AT VARIOUS CITY FACILITIES (Schedule I) as may be required for a period of one (1) year beginning October 1, 1983 through September 30, 1984 at a total estimated annual cost of \$66,011.80; terms net 20 days, with an option to renew contract for four (4) additional one (1) year periods at a price escalation not to exceed 12% of prices in effect at the end of the prior year.
2. That the bid of ELLIS BUILDING MAINTENANCE OF SOUTHERN CAL. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing JANITORIAL SERVICES AT VARIOUS CITY FACILITIES (Schedule II) as may be required for a period of one (1) year beginning October 1, 1983 through September 30, 1984 at a total estimated annual cost of \$48,479.45; terms 2% 20 days, with an option to renew contract for four (4) additional one (1) year periods at a price escalation not to exceed 5% of prices in effect at the end of the prior year.
