BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for OAKS NORTH VILLAS UNIT NO. 4, on file in the office of the City Clerk as Document No. RR-255856, to provide for the substitution of RANCHO BERNARDO DEVELOPMENT COMPANY, a joint venture, for AVCO COMMUNITY DEVELOPERS, INC., a California corporation, as subdivider.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by RANCHO BERNARDO DEVELOPMENT COMPANY, a joint venture, as provided by the amendment to the subdivision agreement, on file in the office of the City Clerk as Document No. RR- 259360

BE IT FURTHER RESOLVED, that performance bond number 39-85-84, issued by Insurance Company of the West, in the amount of \$476,493.00, is hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that performance bond number YS 843-6771, issued by The Industrial Indemnity Company, in the amount of \$476,493.00, is hereby released.
