WHEREAS, Section 8330 et seq. of the Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution; and

WHEREAS, the abutting property owners have requested the vacation of Carroll Ridge Drive adjacent to Lots 17 and 18, and the street reservation in Lot 14, all within Carroll Ridge Unit 1 Subdivision, Map 9411, all adjacent to the Carroll Ridge Business Park IV Subidivision (TM 82-0384) boundary, to facilitate development of their properties; and

WHEREAS, Carroll Ridge Drive adjacent to Lots 17 and 18, Carroll Ridge Unit 1, Map 9411, has been superseded by relocation and is no longer needed for present or prospective public use; and

WHEREAS, the street reservation in Lot 14, Carroll Ridge
Unit 1, Map 9411, is no longer needed for present or prospective
public use; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Carroll Ridge Drive adjacent to Lots 17 and 18, and the Street Reservation in Lot 14, all within Carroll Ridge Unit 1 Subdivision, Map 9411, as more particularly shown on Drawing No. 15852-B, on file in the office of the City Clerk as Document No. RR- 259368-/, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That this resolution shall not become effective unless and until the final subdivision map for the Carroll Ridge
  Business Park IV Subdivision (TM 82-0384) has been approved by
  Council action. In the event that the final map is not approved by September 7, 1987, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.




