HAZARD CONTRACTING COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of April 19, 1983, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 259371, granting to said City an easement for public street purposes in those portions of Lots 14 and 15, Carroll Ridge Unit 1, according to Map thereof No. 9411, together with those portions of Parcels 1 and 2 according to Parcel Map thereof No. 11036, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named ROSEY RIDGE DRIVE.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
