BE IT FURTHER RESOLVED, that the expenditure in the sum of \$25,000 from Fund 18519, Dept. 5717, Org. 1706 (CDBG '83 funds) contingent upon availability of funds from the United States Department of Housing and Urban Development be and it is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.

BE IT FURTHER RESOLVED, that the expenditure of \$19,000 from Fund 185191, Dept. 5733, Org. 3301 (Jobs Bill) for economic development activities in City Heights be and it is hereby approved.
