WHEREAS, under existing law, San Diego County is authorized to have a seven (7) member commission for the Local Agency Formation Commission (LAFCO); and

WHEREAS, AB 1016 (Killea) was passed by the State Legislature authorizing an additional member and alternate thereto to serve on LAFCO, to be appointed by The City of San Diego; and

WHEREAS, such authorization is contained in newly added section 54780.3 to the California Government Code; and

WHEREAS, the additional member and alternate are authorized in said code section to be appointed on January 1, 1984 for a regular term; and


WHEREAS, section 54783 of the Government Code provides that a regular term shall be four (4) years expiring the first Monday in May in the year in which the term is to expire; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Government Code sections 54780.3 and 54783, Councilman Mike Gotch and Councilman Uvaldo Martinez are hereby appointed as the City of San Diego's representative and alternate, respectively, to the Local Agency Formation

Commission, for a term commencing January 1, 1984 and expiring  
the first Monday in May 1988.
