BE IT RESOLVED, by the Council of The City of San Diego as follows:


Said Council hereby finds that certain map surveyed by Robert G. Schoettmer, a licensed land surveyor, entitled "REVERSIONARY MAP OF SAN DIEGUITO ESTATES, being a reversion to acreage of Lots 1 through 39, inclusive, of San Dieguito Estates, according to Map thereof No. 9751, filed in the office of the County Recorder of San Diego County, August 12, 1980, together with Derby Farms Road, Derby Farms Lane, Derby Downs Road and Derby Downs Lane as vacated and closed to public use by filing of the Reversionary Map as provided in Section 66499.18 of the Subdivision Map Act, and including a portion of El Camino Real which remains dedicated to public use, in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
