

RESOLUTION NUMBER R- **259407**

Adopted on OCT 11 1983

WHEREAS, PARDEE CONSTRUCTION COMPANY, a California corporation, subdivider of SAN DIEGUITO ESTATES, desires to abandon said project and file a reversionary to acreage map which will revert the previously subdivided land to acreage, leaving a single lot containing 413 acres; and

WHEREAS, the filing of the REVERSIONARY MAP OF SAN DIEGUITO ESTATES constitutes the abandonment of certain easements and streets shown on said map as Derby Farms Road, Derby Farms Lane, Derby Downs Road and Derby Downs Lane; and


WHEREAS, the dedication of El Camino Real along the west boundary of the property will be retained and be improved by Engineering Permit W26563; and

WHEREAS, in accordance with Chapter 6, Article 1 of the Subdivision Map Act, upon recording a reversionary map, all fees paid by the developer must be refunded; NOW, THEREFORE,
