
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized to accept a letter from Genstar Development, Inc. dated October 11, 1983 with the duly authorized signature of Robert McLeod, Vice President, as an irrevocable offer by Genstar to provide for the improvement of Woodman Street between Alta View Drive and Route 54.

2. That the City Manager be and he is hereby authorized to issue a Public Improvement Permit to Genstar Development, Inc. for construction of Woodman Street as a full-width, 4-lane major street between Alta View Drive and Route 54, including a traffic signal at the intersection of Woodman Street and Route 54, said construction to begin no later than April 1, 1984 and to be completed no later than October 1, 1984 and shall include removal of the existing temporary connection.

3. That the City Manager be and is hereby authorized to obtain such permits as may be required by the County or CALTRANS to affect the connection between Woodman Street and Route 54.
