RESOLUTION NUMBER R- 259431

Adopted on OCT 17 1983

WHEREAS, in 1977, the State of Washington adopted a new juvenile code which instituted uniform, certain and graduated penalties for juvenile offenders; and

WHEREAS, under this law, juveniles receive a numerical score for the offense, their previous criminal history and their age; and

WHEREAS, graduated penalties are based on the score, with some discretion afforded to judges and certain scores result in mandatory incarceration; and

WHEREAS, the City's 1982 State Sponsorship Program included AB 3291 (Stirling) which was patterned after the Washington law, but the bill died in the Assembly Criminal Justice Committee; and

WHEREAS, Assemblyman Stirling reintroduced this concept last year as AB 1186 and we are supporting this measure which has been assigned to the Assembly Criminal Law and Public Safety Committee; and

WHEREAS, the Rules Committee considered the recommendations set forth in IRD Report No. 83-63, dated September 12, 1983, to support AB 1186 (Stirling), voted unanimously to adopt said recommendations, and now forwards the matter to the full Council for consideration and with recommendation for adoption; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that this Council, for and behalf of the people of said City,
does hereby express its reaffirmation of support for the
uniform, certain and graduated penalties for juvenile penalties
as contained in AB 1186 (Stirling).

BE IT FURTHER RESOLVED, that the Council declares its
support for AB 1186 (Stirling) and directs the Director of
Intergovernmental Relations to take appropriate action.
