BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Endorsements 4 and 5 to the contract with PACIFIC GUARDIAN LIFE INSURANCE COMPANY, LIMITED, to (a) extend the contract through June 30, 1984 at the current premium rates; (b) change the contract renewal date from October 21 to July 1 each year; (c) offer employees a choice of two basic life insurance coverages (\$10,000 or one times annual salary) effective February 1, 1984; and (d) clarify the group life insurance eligibility of employees on Long-Term Disability, under the terms and conditions set forth in Endorsements 4 and 5 on file in the office of the City Clerk as Document Nos. RR- 259435 - / and RR- 259435-2.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$198,000.00 from Fund 60026 is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
