BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those easement deeds of R. E. HAZARD CONTRACTING COMPANY, a California corporation, and PACIFIC SCENE PROPERTIES OF SAN DIEGO, a California corporation, dated April 19, 1983; and PACIFIC SCENE PROPERTIES OF SAN DIEGO, INC., a California corporation, dated June 14, 1983, executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents Nos. RR- 259492 - 1 and RR- 259492 - 2, granting to said City easements for a public street, sewer and drainage purposes in portions of Lots 14, 17 and 18, Carroll Ridge Unit No. 1, Map 9411, and the Southeast Quarter of the Northeast Quarter of Section 10, Township 15 South, Range 3 West, San Bernardino Meridian, and in a portion of Parcel 2, Parcel Map No. 12734, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named REHCO ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
