Richard Smith	Water Utilities	\$1,870	Mr. Smith is a Wastewater Plant Operator in the Metro Wastewater Division. One year ago he earned a partial award of \$1,375 for his suggestion to use an existing air line to unload ferric chloride deliveries. One year's experience has shown a savings of \$10,808. This is the remainder of the award.
John Whyte	Fire	\$1,425	Mr. Whyte is a Fire Captain. One year ago he earned a partial award of \$50 for his suggestion to store reserve apparatus equipment in packing crates at primary stations. One year's experience has shown a savings of \$4,910. This is the remainder of his award.
Betty Bixby	Auditors	\$1,135	Ms. Bixby is a Senior Account Clerk. She suggested modifying Form CE-456 B "Approved Subdivision application and Estimated Cost" to be an input document. One year's experience has shown a savings of \$7,609. This is the remainder of her award.
