Craig W. Black	Fire	\$ 860	Mr. Black is a Captain. He suggested the discontinuance of replacing the zipper on the Class B boots. This is expected to save \$5,732 in the first year in equipment replacement costs. This is a partial award pending a final 12 month review.
Charlie Jones	Water Utilities	\$ 720	Mr. Jones is a Plant Mechanic in the Water Quality Division. One year ago he earned a partial award of \$720 for his suggestion to fabricate the bronze cylinders used at the Alvarado Filtration Plant in-house rather than purchase them from a vendor. One year's experience has shown a savings of \$4,804. This is the remainder of his award.
Lou Ann Czerwien	Library	\$ 665	Ms. Czerwien is an Intermediate Typist. She suggested revising the procedure of sorting books received from the branch libraries. This is expected to save \$4,419 in the first year in labor costs. This is a partial award pending a final 12 month review.
