Dennis Marnell Jim Froslic	General Services	\$ 440	Mr. Marnell is a Mechanic and Mr. Froslic is a Service Writer in the Equipment Division. They suggested the correction of the overspeed device on the 5500 series refuse trucks. This is expected to save \$1,460 in the first year in costs for time and material.
James E. Bates	General Services	\$ 405	Mr. Bates is a Buildings Supervisor in the Buildings Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to install linoleum in elevators instead of carpet. One year's experience has shown a savings of \$1,350. This is the remainder of his award.
Paul Powers	General Services	\$ 400	Mr. Powers was an Equipment Service Writer in the Equipment Division at the time he submitted this suggestion. He suggested the relocation of the voltage regulator and relays on the fixed cab master trucks. The actual savings for this modification were \$3,998.
