Rosa L. Biendarra	Auditor	\$ 100	Ms. Biendarra is a Program Typewriter Operator. She suggested the implementation of a filing system for discs and documents for the xerox word processor. Although the savings were difficult to calculate, this was considered to be a significant work quality improvement.
John E. Chaffin	Water Utilities	\$ 100 Merchandise	Mr. Chaffin is an Associate Chemist in the Metro Wastewater Division. He suggested the installation of a compressed gas line to use low purity nitrogen for surge and evaporation of samples. This is expected to save \$668 in the first year in material costs.
Dorothy Koller	Auditors	\$ 55	Ms. Koller is an Account Clerk. She suggested making deposit refunds contingent upon full payment of other accounts with deficit balances. The actual first year's revenue increase is \$189.
