Michael J. Donnelly	Fire	\$ 50	Mr. Donnelly is a Firefighter. He suggested the implementation of an additional safety check of apparatuses with auxiliary pumps. Although the savings were difficult to calculate, this was considered to be a significant safety improvement.
Charles Lyons	Water Utilities	\$ 50	Mr. Lyons is an Equipment Technician II at the Alvarado Filtration Plant. He suggested the replacing of speed control stop set screws on the mixer machines with tee handles. Although the savings were difficult to calculate, this was considered to be a significant operational improvement.
Jon D. McDonald	Fire	\$ 50	Mr. McDonald is a Firefighter. He suggested the fabrication of a cover for the safety net at the training center. This is expected to save \$154 and represents a significant safety improvement.
