Milous L. Wilson William E. Barranon	Engineering & Development	\$ 30	Mr. Wilson and Mr. Barranon are Building Technicians II. They suggested the use of a rubber stamp in identifying and marking certificates of correction on Parcel Maps, subdivision and Records of Survey. The actual savings were \$101 in material costs.
Maryanne Piumatti	Auditor	\$ 25	Ms. Piumatti is an Intermediate Typist. She suggested the mailing of General City Annual Financial Report by packaging via automated/assembly line process in the Print Shop. This is expected to save \$79 in the first year in labor and material costs.
Robert F. Neal	Fire	\$ 25	Mr. Neal is an Investigator. He suggested the replacement of the double key dead bolt on the first floor of Fire Station #1. Although the savings were difficult to calculate, this was considered to be a significant operational improvement.
