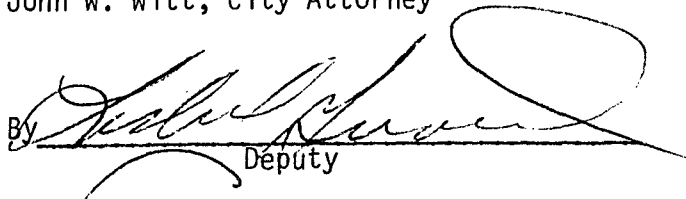
BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$8,000.00 from Transient Occupancy Tax Fund 10223, CIP No. 22-063 TECOLOTE SHORES COMFORT STATION; and \$32,000.00 from Capital Outlay Fund 30245, CIP No. 22-039 ANNUAL ALLOCATION - MISSION BAY - GENERAL IMPROVEMENTS AND LANDSCAPING to CIP No. 22-062 SUNSET POINT COMFORT STATION.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$92,350.00 from Transient Occupancy Tax Fund 10223 and \$32,000.00 from Capital Outlay Fund 30245, CIP No. 22-062 SUNSET POINT COMFORT STATION; and \$102,950.00 from Transient Occupancy Tax Fund 10223, CIP No. 22-063 TECOLOTE SHORES COMFORT STATION is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
