BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF HORSE STABLE IN BALBOA PARK.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 36-043 CONSTRUCTION OF HORSE STABLE - BALBOA PARK to the FY 1984 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$121,000.00 from General Fund 100, Police Department 110, Organization 303 to CIP No. 36-043 CONSTRUCTION OF HORSE STABLE - BALBOA PARK.
