WHEREAS, MVP LAND, a California limited partnership, has requested an exchange of water and drainage easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of MVP LAND, a California limited partnership, executed in favor of The City of San Diego, bearing date of May 27, 1983, conveying to said City water and drainage easements in Parcel 1 of Parcel Map 12637, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 259531 -/, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 259531 -2, quitclaiming to MVP LAND, a California limited partnership, all of the City's right, title and interest in the drainage easement in Parcel 1 of Parcel Map 12637, as more particularly described in said deed.
