BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF MISCELLANEOUS DRAINAGE FACILITIES ON HARBOR DRIVE  
BETWEEN KETTNER BOULEVARD AND FIFTH AVENUE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$58,000.00 from Capital Outlay Fund 30245, CIP No. 58-004 ANNUAL ALLOCATION - MISCELLANEOUS IMPROVEMENTS ON CITY STREETS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
