RESOLUTION NUMBER R-259548

Adopted on November 1, 1983

WHEREAS, Councilmembers Dick Murphy and William Jones sent a memorandum, dated November 1, 1983, to the Mayor and City Council proposing additional personnel for the Police Department to enhance the department's Crime Prevention/Neighborhood Watch Program; and

WHEREAS, the City Council considered said proposal at its regularly scheduled meeting of Tuesday, November 1, 1983 and discussed the matter of adding additional personnel as recommended; and

WHEREAS, the Council voted unanimously to adopt said proposed recommendation, as amended, to provide additional Intermediate Typists only, and it is now necessary that the annual appropriation ordinance be amended to provide for the additional personnel and the necessary funds associated therewith; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations contained in the November 1, 1983 memorandum from Councilmembers Dick Murphy and William Jones regarding additional Community Service officers and clerical staff, as amended by Council to add eight (8) Intermediate Typists only, to provide additional support for the Police Department's Crime Prevention/Neighborhood Watch Program, with quarterly reports to be presented to the Public Services and Safety Committee beginning with the meeting of January 1984, be and the same is hereby approved and adopted.

BE IT FURTHER RESOLVED, that the City Manager is directed to initiate a Request for Council Action to the City Attorney to promulgate the necessary and required ordinance to amend the annual appropriation ordinance to add the additional personnel to the Police Department for the purposes stated above and to provide the necessary funds for said personnel and associated nonpersonnel expenses.
