

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT
BEYER BOULEVARD AND IRIS AVENUE.

BE IT FURTHER RESOLVED, that the total expenditure of \$85,000.00, not to exceed \$80,900.00 from CDBG Fund 185191, Dept. 5731, Org. 3114, CIP No. 62-243 BEYER BOULEVARD AND IRIS AVENUE; and \$4,100.00 from Capital Outlay Fund 30245, CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD & OTHER CITY COSTS FOR FEDERAL GRANT PROJECTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
