APPROVING MAP OF RIDGEGATE LA JOLLA UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Charles W. Christensen, a registered Civil Engineer, entitled "RIDGEGATE LA JOLLA UNIT NO. 2, being a subdivision of Blocks 11, 16, 21, 26, 31, 36 and 41 and Lots 5 through 12, inclusive, of Block 1, Lots 2 through 12, inclusive, and Lots 29 through 40, inclusive, of Block 6, and excepting Lots 9 and 10, Block 36, together with the streets as vacated and closed to public use, all in La Jolla Heights (abandoned), in the City of San Diego, County of San Diego, State of California, according to map filed in the office of the County Recorder of San Diego County June 26, 1905 in Book 364, page 368 of deeds," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: a portion of Soledad Mountain Road, and said portion of said street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1, 2, 3, 4 and 5 of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of street is accepted on behalf of the public as heretofore stated; and that those easements listed in paragraphs 1, 2, 3, 4 and 5 of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
