APPROVING PARCEL MAP T.M. 82-0106

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain parcel map surveyed by Gordon L. McElroy, a licensed surveyor, identified as "Parcel Map T.M. 82-0106, being a subdivision of a portion of Pueblo Lots 1274 and 1276 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County, November 21, 1921 and is known as Miscellaneous Map No. 36," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: a portion of Governor Drive, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said parcel map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Governor Drive, adjacent and contiguous to Parcel 3, all as shown on this map

within this parcel map.

The Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council, that said Council has approved said parcel map and that said portion of a public street is accepted on behalf of the public as heretofore stated and that those certain abutters' rights of access, all as granted and shown on this map within this parcel map are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Engineering and Development Department for further handling.
