Adopted on November 7, 1983


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with FEDERATED DEPARTMENT STORES, INC. for the construction of a traffic signal system at Stone Canyon Road and Pomerado Road, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-259579.

2. That the City Manager be and he is hereby authorized to accept \$4,123 as the developer's estimated fair share of future public facilities needs in the Rancho Bernardo Community.

3. That the City Auditor be and he is hereby directed to establish the Rancho Bernardo Public Facilities Improvement Fund and to deposit \$4,123 in that fund and to credit to that fund all accrued interest thereon.
